### Spring Care Coordination Training Series Begins!

BPHC's Care Coordination Training Series continues this spring. Enrollment is open for these four programs. PPS member organizations are welcome to identify eligible staff to participate. Priority will be given to DSRIP-funded staff who should complete their required BPHC training.

#### April 27 - June 22 (weekly on Thursdays)

##### Care Coordinator Training Program

Nine-day training (63 hours) for Care Coordinators, Depression Care Managers, Nurse Care Managers (and equivalent titles). [Click here](#) for information and to register.

#### April 18 - June 13 (weekly on Tuesdays)

##### Medical Office Assistant Refresher and Certification Program

Nine-day training (63 hours) for Medical Assistants (and equivalent titles). Upon completion, participants are eligible to take the national Certified Clinical Medical Assistant exam on the last day of training. [More](#).

#### April 19 and 24

##### Essentials of Care Coordination Training

Two-day training (14 hours) for all non-care coordination staff (excluding IT) who work with Care Coordinators (e.g. Health Educations, Pharmacists, Pharmacy Techs, registered Dieticians, Population Health Managers, LPNs, CHWs). [More](#).

##### Nurse Care Management Supervisor Training

One-day training (7 hours) for new or experienced supervisors to clarify their role, identify practices they want to improve, and learn strategies to support the care coordination staff they oversee. [More](#).
