DSRIP in its Third Year What it Means for Our PPS

DSRIP has now reached its most important phase to date for BPHC and all performing provider systems (PPSs) in the state.

In April, we began DSRIP Demonstration Year 3 (DY3) and our work has made a significant change in focus as we move from an emphasis on payment for reporting to payment for performance improvement.

Previously, our work was measured by planning and implementation milestones of our 10 DSRIP projects and patient engagement. Today, our focus is on how our work actually provides measureable results that help us achieve better outcomes for Medicaid members.

The NYS Department of Health has acknowledged the great work of all 25 PPSs and is optimistic that we will successfully transform the state's health care system to ensure access to quality care for all Medicaid members. We look forward to keeping you updated on our work.
