Partner Contracts Will Be Released Throughout DY1

During DY1 Q1 (April 1 through June 30), BPHC will be developing project work plans, which outline how our partners will participate in each of our DSRIP projects. These work plans will in turn inform the contracts established between BPHC and our partners. Our Master DSRIP Service Agreement (MDSA) is currently being finalized, and each partner agreement will need to be customized to each partner based on details of the work plans.

We plan to discuss and finalize partner agreements at different points throughout the year, depending on project timelines and the partner's level of responsibility. We will continue to provide information about MDSAs in the upcoming months.

Upcoming Webinar Outlines PCMH 2014 Standards

The NCQA recently announced new standards and rates for incentives under PCMH 2014. To learn more about these changes, please refer to the [PCMH website](#) and pages 23 and 24 of the [March 2015 NYS Medicaid Newsletter](#).

DSRIP requires that all primary care providers attain Level 3 PCMH 2014 recognition by December, 2017. To support this process, the NCQA is hosting two webinars about the standards and guidelines of PCMH 2014. BPHC Reopens CRFP Application Process

Due to a recent amendment from the NYS DOH, we are reopening the CRFP application process. All members who submitted CRFP applications in February are required to resubmit their applications.

Previous applicants may take this opportunity to modify original applications. Please provide specifics of any changes made to the original application. Applications that are not revised must be submitted alongside a Letter of Attestation confirming no changes to the original.

New and revised applications must be sent to LRobertson@bronxphc.org by 12PM on Wednesday, April 29th. Unchanged applications and Letters of Attestation are due to LRobertson@bronxphc.org by than 5PM on Friday, April 24th.
