### Selected Sub-Committee Members Announced Today

We would like to thank everyone who submitted nominations for consideration on the four BPHC Sub-Committees. From a total of 121 nominations representing 62 different organizations, the Executive Committee has selected 15 members for each Sub-Committee. We will send letters congratulating our selected nominees today. The final list of Sub-Committee members will be available on our website next Wednesday, May 13th.

### DSRIP Timeline Changes Affect Valuation and Payment Dates

The NYS DOH recently announced adjustments to the DSRIP timeline. BPHC will now receive our first DSRIP payment from DOH on May 28th. This payment will consist of 60% of this year's total allocation.

Please note that although BPHC will be awarded funds on May 28th, partner contracts will determine when and how these funds will become available to our partners. We will be working with the Executive Committee over the next several months to finalize contract formats and to develop the process for distributing payments. We anticipate beginning to contract with our partners for selected services starting this fall. More information will be forthcoming as we continue to develop this process.

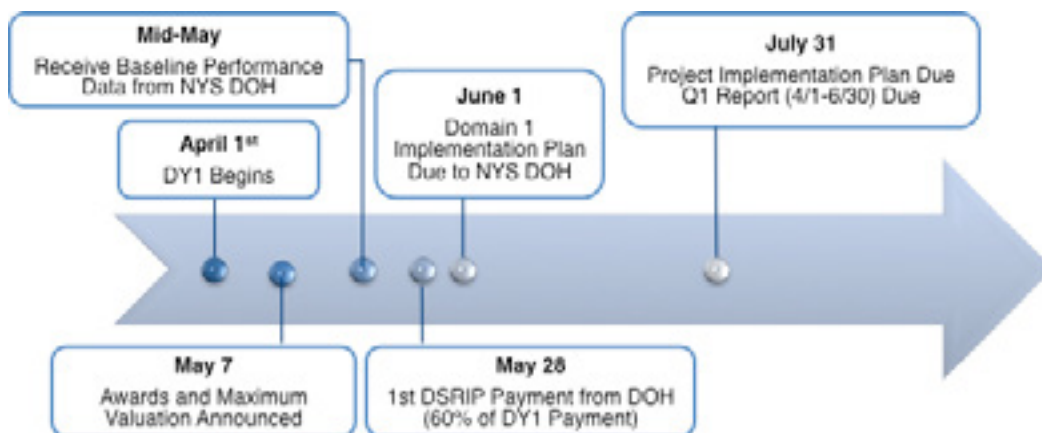
## In Case You Missed It

The final deadline for new and revised CRFP applications ended last Wednesday, April 29th. We have reviewed all applications and will submit them to NYS DOH by 5 PM today.

### NYS DOH Announces Revised DSRIP Timeline

Here is a summary of the revised DY1 Q1 timeline:



The NYS DOH has also extended the DSRIP period by one quarter. Originally ending on December 31st, 2019, the DSRIP period will now run through March 31st, 2020 for a series of 20 consecutive quarters.

In addition, a new requirement is that we also submit Project Implementation Plans, which are work plans specific to each of our clinical projects. We will submit all Project Implementation Plans by July 31, 2015 along with the First Quarterly Report.
