NYS DOH Delivers Valuation Award Letter

On Monday, May 11th, we received a letter from the NYS DOH announcing our PPS's final valuation. BPHC may be awarded a maximum of \$240M for meeting the requirements provided by the State and the milestones outlined in our Implementation Plan. In addition, the PPS is guaranteed approximately \$105M from a Safety-Net Equity fund, distributed annually over the next five years. These combined funds of \$346M will be used as the basis for implementation plan budgeting. If the PPS is able to significantly exceed our already challenging expectations, it may be eligible for up to \$38M in High Performance Funds.

BPHC will receive the first allotment of DSRIP funds on Thursday, May 28th, amounting to 60% of the total allotment for DY1. Partner contracts will outline the process and timeline for distributing these funds to our partners. We anticipate beginning to contract with our partners for select services this fall.

Bronx RHIO Provides Access to Comprehensive Patient Information

To achieve PCMH 2014 recognition, and therefore to implement DSRIP projects, it is vital that our providers access and share comprehensive patient information. The Bronx Regional Health Information Organization (Bronx RHIO) connects our partners through a single health information exchange, consolidating information from everywhere a patient receives care into one complete record. This allows our providers to accurately track service usage over time for individual patients and monitor the health status of larger populations.

Bronx RHIO Accepting Applications for Participation

We are asking that every provider in our PPS participate in the Bronx RHIO by December, 2017. To begin this process, please submit a completed Application for Participation and a Participation Agreement to the RHIO.
