BPHC Partners to Enter Master Service Agreement (MSA)

Over the course of DSRIP project implementation, many members of our PPS will enter into a financial agreement with BPHC. These organizations are considered BPHC Partners, whereas organizations who participate in BPHC, but do not enter a financial relationship, are BPHC Members. Both Partners and Members have a critical role in project implementation and healthcare transformation.

The framework for the relationship between Partners and BPHC will be outlined in a Master Service Agreement (MSA), and accompanying Schedules will establish specific roles and responsibilities by project. We are currently developing the MSA definitions, and a draft is available for entire PPS to review. On May 28th, BPHC hosted a webinar about the MSA for 60 attendees, which can be found on our website for those who could not attend.

Your Feedback Guides MSA Development

To ensure that the MSA takes into consideration the diverse needs of our PPS, we are reviewing and discussing your feedback on the MSA. Those who submitted the Comment Matrix may attend a webinar on June 24th for further discussion. After making necessary revisions, we will distribute final the MSA on June 26th, after which point the MSA will not change. Additional Exhibits may be created as necessary, and Schedules will be negotiated with each partner individually.

IFH's Virna Little Will Present on Behavioral Health Integration

Virna Little from the Institute for Family Health, who is leading our PPS's efforts in integrating primary care and behavioral health, will deliver a presentation about the IMPACT model for behavioral health integration to New York's PPS Clinical Leadership. BPHC Received First DSRIP Payment

On May 28th, BPHC received the first payment of DSRIP performance funds, linked to the successful submission and approval of the Implementation Plan. The first payment was 60% of the total allotment for DY1, for a total of \$16M. The process and timeline for distributing DSRIP funds to our Partners will be outlined in the Master Service Agreement and accompanying Schedules.

BPHC Submitted Domain 1 Implementation Plan on Monday

On Monday, June 1st, we sent our completed Domain 1 Implementation Plan to the NYS DOH. In it we proposed the steps and strategies that we will take to meet milestones defined by the State. We will receive DSRIP funds based on our performance on these deliverables and those outlined in our Project Implementation Plans. After receiving comments from an Independent Assessor, we will finalize the Domain 1 Implementation Plan on July 30th.
