# **On the Horizon**

## **PCMH** at the Heart of Healthcare Transformation

BPHC is about more than implementing DSRIP projects - it is about working together to improve population health by delivering coordinated, value-based, patient-centered care far beyond 2020, when DSRIP ends. Similarly, achieving PCMH 2014 Level 3 recognition is more than a DSRIP requirement – Patient Centered Medical Homes are at the heart of healthcare transformation and establish a robust primary care foundation from which DSRIP projects can be built and sustained.

The journey to achieve NCQA PCMH Recognition can be challenging, potentially requiring significant expertise and investment of time and resources. Once it is achieved, however, PCMH recognition positions providers to receive enhanced capitation rates and performance incentive payments in the short term, and helps to prepare providers for value based contracting arrangements in the long term.

Furthermore, widespread achievement of PCMH Recognition will ensure that BPHC meets DSRIP performance and patient engagement targets, which will result in enhanced DSRIP payments to BPHC members.

## **Outside Vendors to Support PCMH 2014 Transition**

BPHC is committed to supporting primary care providers in our PPS in achieving PCMH 2014 Level 3 recognition. BPHC's CSO is currently working to select and engage experienced PCMH consultants to assist with this process. While consulting services may be limited, we aim to provide these services to every interested BPHC primary care provider, including independent practices that have not had an opportunity to apply for 2008 or 2011 PCMH recognition.

## The Process for Contracting With PCMH Consultants

PCMH consultants submitted Letters of Intent on Monday, June 15th, which outline their expertise and experience with PCMH implementation and their application and practice transformation strategy. This information will be used to align consultants with provider organizations and practices in BPHC.

After the CSO, consultant, and partner reach a mutual agreement on the scope of work and the process for achieving PCMH recognition, the CSO will contract for agreed upon consulting services with DSRIP funds. PCMH consultants will then work directly with primary care providers to help them meet PCMH 2014 standards and develop and submit their PCMH application.
