Survey Distributed to Profile Community-Based Services in BPHC

We have recently learned a great deal about the healthcare services available within our PPS, but BPHC has also distributed a survey to learn more about the communitybased services our PPS members provide.

Many PPS member organizations, from hospitals to community-based organizations, offer social support services to keep their communities well, safe, and connected to care. Our PPS will integrate these services into DSRIP projects to address the social and cultural factors that lead to or exacerbate health conditions.

Upcoming Discussion Sessions about Community-Based Services

On Wednesday, June 24, we held a conference call with over 60 participants to discuss the comments we've received from our members about our Master Service Agreement (MSA). We incorporated this feedback into the MSA and plan to present the revised document to the Executive Committee for final review and approval at their meeting on July 23. We will distribute the final MSA to the PPS on July 30, after which point no changes will be made to the documents.
