## **Public Comments Invited for DSRIP Waiver Extension**

The NYS Department of Health released for public comment a proposal to extend New York's Delivery System Reform Incentive Payment (DSRIP) waiver for an additional four years and seek \$8 billion in federal funding for continued support of health care transformation in the state. The current waiver ends on March 31, 2020.

Public comments are due by November 4 prior to DOH"s submission of a formal waiver extension request to the Centers for Medicare and Medicaid Services (CMS). Comments may be submitted as follows:

**Public Comment Day** Friday, October 25 11 a.m. - 2 p.m. (registration begins at 10:30 a.m.)

The meeting will be open to the public and webcast live. No pre-registration is required. Those wishing to provide comment should register on site before Noon and will speak in order of registration. Comments should be limited to five minutes per presenter to ensure that all comments are heard.
